Subject: Increase in wages of Data Entry Operators in DDMA.

I am directed to convey the approval of competent Authority for the revision in the wages and payment to Data Entry Operators (Graduates and above) working in the all Delhi Disaster Management Authority (DDMA) in pursuance of the order of the revision of the minimum wages issued by the Labour Department, GNCTD vide order no. F.N. 12(142)/02/MW/VII/5063 Dated 10.11.2014 and order No. F.No. 12(142)/02/MW/348 Dated 31.03.2015.

“Therefore, as per the above mentioned orders of Labour Department, the salary of Data Entry Operators shall increase from Rs. 11,310/- to Rs. 11,414/- w.e.f. 01.10.2014 and further revision of salary from Rs. 11,414/- to Rs. 11,986/- w.e.f. 01.04.2015.”

The Expenditure on this account is debitable to MH 2245 (Relief on account of Natural calamities), Sub Major Head-“80” (General), Minor Head “102” (Management on National Disaster Contingency) plan in Disaster Prone Area), Sub Head-96: 00: 42-Disaster Management Cell (Plan) under Demand no. 10 for the financial year 2015-16.
