ORDER

Sanction of the Lt. Governor, Delhi is hereby conveyed, for creation of following temporary posts in Department of Women and Child Development, Govt. of NCT of Delhi, for implementation of the provisions of the Protection of Women from Domestic Violence Act, 2005:-

Posts of Protection Officer on notification of the RRs, shall be filled in on regular basis and that of Data Entry Operators through out source basis from empanelled agencies of Information Technology Deptt. GNCTD.

These posts shall run concurrently with the plan scheme "Protection of Women from Domestic Violence Act, 2005- B-2" and shall be renewed on year to year basis. Salary and other expenses in respect of incumbents appointed against these posts shall be booked to the Head of Accounts of the Scheme of the relevant years.
