ORDER

Approval of the competent authority is hereby conveyed for continuation of two temporary posts of Assistant Programmer "B" to be deployed on outsourced basis from M/s National Institute of Electronics and Information Technology (NIELT) for the period 01.03.2015 to 29.02.2016, on existing terms and conditions and remunerations. These posts had been created in the Department of Women and Child Development Vide Letter No.F.1(144)/PC/JJB/06-07/Pt. File/DWCD/Admn/22929-940 dated 31.10.2012 for implementation of provisions of Juvenile Justice (Care and Protection of Children) Act, 2000.

Above extension of continuation of posts is subject to following conditions:-

01. Provisions of funds to meet the expenditure on remuneration of the outsource staff is made in the RE/BE of relevant period.
02. Funds as allotted in Budget are released by Govt. of Delhi during the relevant financial year.
03. Posts are required for due discharge of the duties for implementation of the scheme during the relevant period for which the continuation is approved.
04. The Scheme for which the posts are created remain operational during the relevant period.
05. Agreement with the manpower providing agency should be valid as per specification of IT Department.

Expenditure involved on meeting the expenditure on consolidated remuneration of incumbents provided against these posts shall be debitable to the Major Head "2235", B (2) (1)(2) (24) Plan, Implementation of Juvenile Justice (Care & Protection of Children) Act, 2000, under demand No. 8 for the Financial Year 2015-16.
