ORDER

Other terms and conditions of the arrangement, as incorporated in the agreement, shall be binding on both the parties.

ICDS Branch, WCD-HQ, while forwarding the monthly attendance reports of above outsource staff to Intelligent Communication System India Limited (ICSIL) for generating invoices toward remunerations shall ensure that the staff have actually performed their duties in the projects up to the satisfaction of the CDPO/Branch-In-Charges, during the relevant period for which remunerations are claimed and their bio metric attendances are available on records.

Expenditure involved on meeting the expenditure on monthly remunerations of incumbents deployed against above posts shall be debitable to Head of Accounts ICDS (General) CSS(Plan)-2235 02 102 55 0042; and ICDS (General) State Share (Plan) 2235 02 102 29 0042 for the Financial Year 2015-16.
