ORDER

Sanction of the Lt. These posts are to be filled up on deputation basis from amongst the personnel's of Delhi Police, on the terms and conditions decided by the Department of Women & Child Development, Govt. of NCT of Delhi in consultation with the Delhi Police by granting next higher pay scale/grade pay of the rank existing in Delhi Police as per detail below:-
