ORDER


Sanction of competent authority is hereby conveyed for deployment on outsource basis of 5 (Five) incumbents to the posts of Counselors, created in various children Homes vide order No. F. 6(48)/DWCD/Admn./JJ Act Posting/2013/11478-517 dated 03.07.2014, for a period of one year or till the regular appointment is made subject to the following conditions:-

1. Funds are available
2. The Recruitment Rules for the post be complied while making deployment of the incumbents
3. Codal procedures as provisions of GFR are followed.

The staff so deployed shall be paid consolidated remunerations of Rs. 27,000/- per month subject to satisfactory work appraisal. They shall perform their duties in the respective homes of their deployment under the empanelled Mental Health Unit Service Providers. Their performance shall be scanned by the Monitoring Committee, which comprises of Professionals from IHBAS, AIIMS, Delhi University and Hospitals, constituted vide order dated 16.09.2014.

This issues with the concurrence of Finance Department vide their U.O.No. 240/DS-V dated 10.11.2015.


