
With reference to pay fixation order No. F.2(4)/PF/SSH/WCD/2009/2014-15/36734-39 dated 10.12.2015, Ms. Saroj Arora, Retired Welfare Officer has submitted representation in this Office on 16.12.2015 (Copy enclosed) alleging that the pay fixation has not been done correctly as per rules FR 22(1)a(1) on various dates. It is admitted fact that while fixing the pay of Ms. Saroj Arora, Welfare Officer (Retired) pay scale as admissible to her under M.A.C.P. Scheme, as recommended by the 6th Pay Commission has not been taken into consideration, as such to grant her the same it is requested that duly filled proformas as per specimen enclosed, with her last work and conduct report, last vigilance clearance report and service verification chart with certificate on no break in service with her Service Book may please be submitted to this office immediately, so that the Screening Committee of the Department, as constituted for grant of ACP/MACP benefits to the staff of DWCD may consider the case and on its recommendations the pay scale as admissible under MACP may be granted to her.

With regard her contention that payment on account of interest @ 10% on all belated payments has not been released to her, it is requested that the same may please be clarified and payment be got released immediately. For non encashment of cheques toward retire mental dues of Ms. Arora which were mailed to Ms. Saroj Arora through speed post, it is suggested that the matter for issuance of fresh cheques may be taken up with the Pay and Account Office as the validity of the cheques already stand expired. PAO may be requested to scrutinize their records regarding non encashment of such cheques and issue fresh cheques which can be handed over to counsel of Ms. Arora during hearing of the court case on 18.12.2015.

Since Contempt Petition is to come up for submission of compliance, on 18.12.2015, as such immediate steps may kindly be taken on priority.
