NOTE FOR THE COUNCIL OF MINISTERS

Subject: Abolition of affidavits/attestation and adoption of self certification.

Background:

- Citizen centricity is the essence of any vibrant democracy and is inextricably linked to good governance. Good governance basically means creating an environment in which all classes of citizens can develop their fullest potential. It also means provision of public services in an efficient and equitable manner to citizen.
- 2. With the above position in view, Administrative Reforms (AR) department, carried out a review of various administrative processes for deliverance of services which are essential to citizens. In this exercise, it came to light that many affidavits are being sought by various Departments, though they have no specific sanction of law. It was also revealed that such affidavits are causing a big hindrance in timely delivery of services, imposing cost on the citizens in terms of money, time and efforts. In certain public dealing Offices, signing of affidavits by Government officers brings additional burden of work.

- 3. Examination of the matter from administrative point of view showed that self certification of facts by the citizens while applying for deliverance of services may replace requirement of affidavits. Accordingly an undertaking to replace unnecessary affidavits was drafted and got duly verified from Law Department of GNCT of Delhi. The basic philosophy is to trust the citizen and in case trust is broken, penal action to be taken in a swift and certain manner. The legal position with reference to penalty under IPC for affidavits as well as self certification remains the same and in fact no department has proceeded against any wrong affidavit so far.
- 4. In above background, after the review of affidavits being sought by various Departments/ Autonomous Bodies/ Boards/ Corporations/ Universities/ Local Bodies/ DISCOMs/ Commissions of GNCT of Delhi and Delhi Police, it is revealed that 200 affidavits are not necessary and these are not required under any statutory or legal provisions. List of such affidavits is placed at Annexure-A to the proposal. These affidavits may be replaced by self certification/undertaking/declaration.
- 5. A separate proposal to amend IPC Section 177 and 191 making wrong self certification cognizable and non-bailable offence, will also be moved separately to the Government by Administrative Reforms Department. This is required as the onus now shifts to the citizens and any wrong self certification should lead to certain and swift punishment.
- 6. Comments of Finance and Law Departments of GNCT of Delhi have been obtained and response of the AR Department is as under:

- (B) It has been ensured after obtaining written information and consultations held with the Departments through meeting at the level of Secretary(AR) and Pr. Secretary to CM that these affidavits are not required under any statutory or legal provisions and it is not in violation of any statutory provisions.

2 Law Department (Annexed at D) :

- (A) Thus wherever there is any statutory requirement for furnishing of affidavit, the condition to furnish affidavit cannot be waived off by way of a cabinet decision only. Such statutory provision will also require necessary amendment in the Act for deleting the provision, which requires affidavits.
- (A) The proposal before the Council of Ministers is regarding affidavits which are being sought without any legal sanction. It does not cover affidavits being obtained under statutory provisions.

(B) The Administrative Department may, however, consult the Planning Department and Finance Department.

(B) Comments of Finance department has already been obtained on the proposal . As the matter is administrative in nature there is no involvement of Planning department in any of the aspects of the proposal.

ORDER

The Council of Ministers, Govt. of NCT of Delhi, vide its decision No.2238 dated 03.11.2015 has decided to abolish the following affidavits in Directorate of Education with immediate effect:

Affidavit regarding not being blacklisted & not providing false information in 01. reference to various tenders of procurement, printing & distribution of books and other materials.

Affidavit regarding acceptance of all the terms & conditions of tender documents. 02. Three Affidavits (S.No. 3-5) from sports person during submission of application for Rajiv Gandhi State Sports Award to the effect that :

He has not represented any other state or body in national level games; 03.

He has not received any similar award from any other state/UT and; 04.

He has not been found positive for use of any drugs banned by the international 05. Olympic Committee in any laboratory by the IOC/IOA.

Affidavits are also taken from the students at the time of admission in Patrachar 06. Vidyalaya regarding Date of Birth & the fact that the child has previously studied in a recognized/Govt. Institution or privately.

The following affidavits(S. No.7-10) are also obtained from private schools seeking recognition under the DSEAR, 1973 & RTE Act, 2009:-

The society /Trust will run the school under the provisions of the DSEAR, 1973. 07.

08. That no Governing body members are in blood relation.

That the members of the GB are not in Govt. Service and if they are then the NOC 09. of the employer has been obtained.

That the school shall abide by the provisions of the DSEAR, 1973 and the RTE 10.

Act, 2009 as well as the orders dated 04.05.1997 and 15.12.1999.

At the time of initial appointment affidavit is obtained from the candidates 11. regarding the authenticity of the certificates and documents submitted by the candidate.

abolished affidavits may be replaced certification/undertaking/declaration. A model of which as approved by the Law Department is enclosed. It may be modified by the Departments concerned in accordance with their specific administrative requirements relating to the subject matter.

The department may also consider the following:

i. To check and decide whether the department can do away with the requirement of

undertaking also in respect of the abolished affidavit.

ii. To check and decide whether any alternative document can replace the undertaking thereby doing away with the requirement of undertaking in respect of the abolished affidavit.

The department shall issue necessary orders to its offices/branches/sub-ordinate offices/attached offices/ autonomous bodies/corporations/boards etc. under the administrative control of the Department for compliance of the decision of the Council of Ministers as communicated above.

A copy of the order issued to the effect shall be furnished to AR Department by 04.12.2015.
