ORDER

In compliance of the Orders dated 18.03.2016, issued by Hon'ble Civil Judge (Central District), Tis Hazari Courts, Delhi, in suit No. 20/15 of "Syndicate Bank Vs Sh. Tuhi Ram and Sh. $$\begin{aligned} \text{Attachable Amount} &= \frac{(\text{Basic Pay} + \text{Grade Pay}) - 1000}{3} \\ &= \frac{(8660 + 1900) - 1000}{3} = ₹ 3187/- \text{ p.m.} \end{aligned}$$

The above attachable amount shall change in case of change in Basic Pay or Grade Pay of any of the above officials due to annual increment/refixation of pay, if any, during the period of 24 months w.e.f. the salary for the month of April-2016.
