Complaint against the corruption done by the senior officers of Delhi Fire

Service.

Sir.

In reference to the letter No. PMOPG/D/2016/0255226 dated 06.09.2016 of Prime Minister's Office and letter No. 15(4)/2016/Complaints/Home-III/1354 dated 23.09.2016 of Home Department, you are informed that the Grade I Fire E Course conducted by the IFE(India) is recognized by the Ministry of HRD, Department of Education, Govt. of India for appointment to the post of Divisional Officer/ Asstt. Divisional Officer and below in Central and state Govts./ Public Sectors and Local Bodies & Industries Fire Services as per the Office Memorandum Vide No. F. 18-1.2/78-T.7/T.12 dated 30.04.1983 of Ministry of Education and Culture (Department of Education). The copy of OM dated 30.04.1983 is appended at **Annexure-A**.

All the DPC held in the office of Delhi Fire Service, were according to the DOP&T guidelines, Recruitment Rules and Reservation Roster. The complainant is trying to deface the integrity of Delhi Fire Service and Delhi Fire Service is working with sole motto 'WE SERVE TO SAVE'.

Moreover, a Writ Petition No. 3138/2016 was filed by the complainant in Hon'ble High Court of Delhi on the same ground vide which the Hon'ble Court directed that the petitioners have impleaded respondent No. 4 namely the Institute of Fire Engineers(India) and the President and General Secretary of the said Institute as respondents No. 5 & 6 will not be a ground for filing the present petition in this Court. This is a purely a service matter, for which the petitioners ought to have approached the Central Administrative Tribunal. The present petition is accordingly disposed of alongwith the pending application with liberty granted to the petitioners to approach the Central Administrative Tribunal, for appropriate relief. The copy of order dated 26.05.2016 is appended at Annexure-B.

And, now, an OA No. 2606/2016 has been filed in the Hon'ble Central Administrative Tribunal which is pending and the matter is listed for hearing on 29.11.2016. The copy of daily order sheet dated 04.10.2016 is appended at **Annexure-C**.

You are therefore informed that the matter is subjudice in the Hon'ble CAT and requested to wait for the valuable judgment in the said OA.
