FIRE SAFETY CERTIFICATE

Certified that Vasundhara Co-operative Group housing Society Ltd, Plot No.44, Sector IX, Rohini, Delhi comprised of Five blocks, Ground + three upper floors & two blocks ground + seven upper floors owned/occupied by Vasundhara Co-operative Group housing Society Ltd, was issued fire safety certificate by this department vide letter no. F.6/DFS/MS/CGHS/96/1531 Dated 18/11/1996. The premises was re-inspected by the officer concerned of this department on 06/11/2015 in the presence of Sh. S. C. Dhawan (Secretary) and found that the building have complied with the fire prevention and fire safety requirements in accordance with rule 33 of the Delhi Fire Service Rules, 2010, and premise is fit for Class Residential with effect from 13 / 01 / 2016 for a period of Five years in accordance with rule 36 unless renewed under rule 37 or sooner cancelled under Rule 40 and subject to compliance of the conditions under rule 38 of the Delhi Fire Service Rule, 2010.

1. Means of escape shall not be kept locked or bolted from outside and shall be easily open able by guests in an event of emergency.
2. All employees shall be acquainted with the use and maintenance of all the fire fighting installation/equipments.
3. The fire suppression / protection arrangements provided in the guest house are to minimize losses, if maintained in good working condition. These systems cannot give any guarantee that there will be no fire or losses in the event of one.
4. Any loss of life and property due to non-functional of fire safety arrangements and other installations shall be the responsibility of the licensee.
5. This report may not in any way be treated as regularization of unauthorized construction, if any.
6. The owner/occupier shall apply for renewal of this Fire Safety Certificate to the Director of Form 'J' [sub rule (1) of rule 37] along with a copy of this Certificate, six months prior to its expiry".
7. The owner / occupier shall submit a declaration every year in form "K" provided in the first schedule of Delhi Fire Service Rules 2010. The form is available on WWW.dfs.Delhigovt.nic.in
