**ORDER**

This order will dispose off an appeal received on 21.9.2015 filed by Shri Omkar Singh Namdhari, under Section 19(1) of RTI Act-2005.

The matter was taken up for hearing on 8.12. 2015. Present Shri Omkar Singh Namdhari appelland and the Shri Chander Parkash, APIO/ ZRO(N)-II for PIO. The appelland has stated in his application that neither information has been provided against his RTI application nor his grievance has been resolved. After hearing the appelland it has been observed that basically, the appelland has grievance regarding bifurcation of his bill raised by the department to enable him to claim the same from his tenant who has vacated his properties. He further submitted that he has been requesting for the same from time to time but action has been taken by the zonal office. The APIO stated that the bill has already been recast on the basis of actual consumption recorded on the request of the appelland. After going through the documents, it appears that some more efforts can be made to resolve the grievance. Accordingly, PIO is directed to look into the matter once again and resolve the issue in the capacity of Dy. Director of area within a period of 15 days after issue of this order. Further, the information, if not provided earlier, be also provided to the appelland along with the communication related to above grievance.

In the light of above the appeal is accordingly disposed off.
