## **ORDER**

This order will dispose off an appeal received on 16.10.2015 filed by Shri Pardeep Kumar Pandey, under Section 19(1) of RTI Act-2005.

The matter was taken up for hearing on 17.12. 2015. Present Shri Pardeep Kumar Pandey, appellant and Shri Ram Niwas, APIO/ZRO (SZ)-I on behalf of the PIO. The appellant stated that he has not received the complete information from the PIO so far. The APIO/ZRO(S)-I stated that the information related to his zone has already been sent to the appellant. After going through the RTI application filed by the appellant, it has been observed that he wanted consolidated information related to all zones of DJB. PIO/Jt/Director (Rev)HQ is directed to collect the relevant available information from all zones and sent the same in a compiled form to the appellant within 30 days of issue of this order. The ZRO(Rev)HQ who was present in the chamber of FAA during the course of hearing was also directed to take necessary action in this regard.
