ORDER No. 286

WHEREAS, an In house inquiry was conducted by A.C.(L&E), being Inquiry officer on 17.08.2015 against the official of A.C.(G)-I in the case of inordinate delay in issuing the retirement orders in respect of Shri Zile Singh, Beldar C/o. E.E.(West)-II who had applied for voluntary retirement w.e.f. 31.03.2015 (A.N.).

AND WHEREAS, a notice in this regard was issued to the dealing assistant Sh. Rajender Singh Rawat, UDC who appeared before A.C.(L&E) on 16.09.2015 and submitted that the case for approval of request for voluntary retirement in respect of Sh. Zile Singh was put up on 16.02.2015 by Shri Suraj Pal, LDC the then dealing assistant and the proposal was approved by the competent authority and PF&SB of the individual was received by office of AC(G)-I on 26.02.2015. However the orders for VRS were not issued in time. He has further submitted that he had joined the office of A.C.(G)-I on 27.04.2015 and had taken over charge from Sh.Suraj Pal, LDC on 12.05.2015.

AND WHEREAS,, considering upon the fact that the alleged lapse for not issuing the orders regarding voluntary retirement of Sh.Zile Singh had occurred during the period when Shri Suraj Pal was the deaing assistant, a notice was issued by the Inquiry Officer to Shri Suraj Pal, who had appeared on 28.09.2015 and submitted a statement vide which he has stated that the said lapse of not issuing order of VRS occurred due to his oversight and lack of experience and he has requested that he may be forgiven for the said mistake and that he would be careful in future.

The matter was placed before the Director (A&P) who, in the capacity of Disciplinary Authority, has ordered to issue a warning with the directions to be careful in future while performing his duties in the office.

NOW THEREFORE, the above said decision of the Competent Authority is hereby communicated for information of Sh. Suraj Pal S/o.Sh.Nathu Ram, LDC C/o. S.E.(East), Chitra Vihar.
