The officials concerned may be allowed to exercise their options, if any, under FR-22 (I) a (1) within one month of the issue of the order, granting the financial up-gradation under the MACP scheme.
- At the time of fixation of pay of the above employee, the DDO shall again confirm that the concerned officials either have completed 10/20/30 years of regular service or he has spent 10 years continuously in the same grade pay for grant of benefit of 1<sup>st</sup>/ 2<sup>nd</sup>/ 3<sup>rd</sup>/ financial up-gradation under MACP Scheme without any break or unqualified service.
