Sir/Madam,

I am directed to say that one post of Registrar in PB 3 Rs.15600-39100 + GP Rs.6600/- and one post of Assistant Registrar in PB 2 Rs.9300-34800 + GP Rs.5400/- are to be filled up on deputation basis in North Delhi Municipal Corporation from eligible and willing officers. As per Delhi Municipal Corporation Appellate Tribunal (Registrar and other Staff) Conditions of Service Rules, 1986, the criterion for appointment to the aforesaid posts are as under :-

1. Registrar (PB-3 Rs. 15600-39100 + GP 6600/-)

Officers of Central Government/State Govt./Local Bodies possessing:

- I Degree in Law from a recognized university and
- II with 05 years' legal experience in PB-3 Rs. 15600-39100 + GP 5400/-

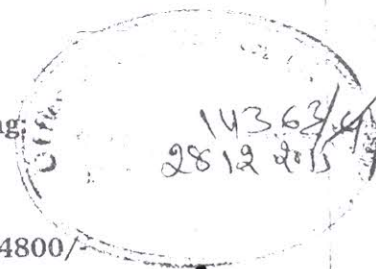
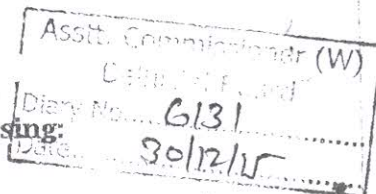
Assistant Registrar (PB-2 Rs. 9300-34800 + GP 5400/-) :-

Officers of Central Government/State Govt./Local Bodies possessing:

- I Degree in Law from a recognized university and
- II with 02 years' legal experience in PB-2 Rs. 9300-34800 + GP 4800/-
- II with 03 years' legal experience in PB-2 Rs. 9300-34800 + GP 4600/-

are eligible for appointment to the aforesaid posts in the Appellate Tribunal in North DMC. The period of deputation shall ordinarily not exceed 3 years.

2. Since, the North DMC follows the Rules/Regulations/Instructions of the Govt. of India, the laid down terms and conditions of deputation of the Govt. of India shall be applicable mutatis mutandis to the officer on deputation basis in North DMC. Further, the maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of receipt of applications.
