Sub:- De-panelment from the list of empanelled Health Care Organization under Delhi Jal Board.

With reference to above mentioned matter the undersigned is directed to draw attention to Office Order No. 24 dated 30.10.2015 vide which i) ASG Eye Hospital, Ghaziabad ii) Srivastava MRI & Imaging Centre – Mayur Vihar, Phase-2, Delhi iii) 32 Pearls Multi-Specialty – Dental Clinic, Vijay Nagar, New Delhi were empanelled under Delhi Jal Board on the pattern of CGHS/DGHS for the purpose of providing medical treatment facility to the beneficiaries of DJB subject to the condition that the empanelment will be for a period of one year or till the Hospital/Diagnostic Centre remain empanelled with CGHS/DGHS, whichever is earlier and CGHS has de-panelled 03 hospitals from its list recently.
