In order to decide the applications of dependents of deceased employees for grant of appointment on compassionate ground, meetings of the Departmental Compassionate Appointment Screening Committee duly constituted by the competent authority were convened on 04.08.2015 & 11.01.2016 in which 603 cases (487 new cases & 116 review cases) were scrutinized.
