Subject: Fixation of pay of Head Clerks-clarification regarding.

Department of Expenditure, Ministry of Finance, GOI Vide OM dated 14.12.2009, revised the pay scale of Assistants who were in the scale of 6500-10500 in PB2 with Grade pay of 4600 and on the same analogy, GNCT has also revised scale of DASS cadre who were in the scale of 5000-8000. DJB has also extended the same to Head Clerks who were in the pay scale of 5500-9000.

However, some of the Accounts personnel were of the view that fitment table of 7450-11500 was applicable in case of existing scale of 6500-10500.

Therefore, the matter was referred to services department of the Govt. of NCT of Delhi for clarifications vide Addl CEO letterNo.DJB/AO(F&G)/2015/357 dated20.10.2015 and 30.11.2015 It has been clarified by the Services Department that pay will be fixed according to clarification issued by Department of Expenditure, Ministry of Finance, Govt. of India vide MOF D/o expenditure I.C.N.O. no. 10/01/2009-IC dated 14.12.2009.

It is also pertinent to mention that the scale of 5000-8000 in GNCT has also been extended in the above scale and the following department have implemented it in the same manner:

- 1. Registrar of Cooperative Societies GNCTD
- 2.. Lokayakta Office of GNCTD
- 3.. Medical Supdt. Rao Tula Ram Memorial Hospital
- 4.. Forensic Science Laboratory is Placed
- 5.. Delhi Subordinate Services Selection Board

Since the pay scale of PB-2 with GP of 4600 in the revised pay structure is the FITMENT table of 7450-11500 and the department has extended the pay scale to its employees who opts under Rules 5 of CCS Revised Pay Rules, 2008—in cases where a Government servant has been placed in a higher pay scale between 1.1.2006 and the date of notification

of these Rules on account of promotion up-gradation of pay scale etc,' the Government servant may elect to switch over to the revised pay structure from the date of such promotion, up gradation ,etc.

Hence, the employees who were promoted or got financial up gradation under ACP between 1.1.2006 to 31.8.2008 will get the benefit of pay fixation directly under these rules. Thus, the pay would be regulated accordingly.

In the event of any adverse/contrary Order of any Court of law or any Order of the Government /Competent Authority to this effect, the beneficiary shall be liable to refund the entire money so received by him.

This issues with the approval of competent authority.
