2. The contractual engagement can be terminated by the Department at any time without assigning any reason or notice.
3. The Department will not bear any kind of liability/responsibility during the period the candidate remains on contractual appointment with DJB except of payment of remuneration fixed by the Department for per month for his/her service rendered to the Department.
4. The candidate shall have to give one month notice or deposit an amount equal to one month remuneration if he wishes to terminate the contract.
5. His/her engagement on contract basis may be terminated at any time in case his/her performance/attitude is found unsatisfactory without any notice.
6. Canvassing in any form will render the candidate disqualified from the post.
