- b) At the time of fixation of pay of the above employee, the DDO shall again confirm that the concerned officials either have completed 10/20/30 years of regular service or he has spent 10 years continuously in the same grade pay for grant of benefit of 1<sup>st</sup>/ 2<sup>nd</sup>/ 3<sup>rd</sup>/ financial up-gradation under MACP Scheme without any break or unqualified service.
- c) The financial up-gradation is merely placement in higher grade pay and this does not amount to functional/regular promotion or seniority benefit etc
- d) The financial up-gradation is subject to verification of Audit.
- e) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.
- f) The DDO concern shall also ensure/verify that none of the employee recommended by DSC has been granted any in-situ or other financial up-gradation under ACP scheme/promotion respectively.
