ORDER NO. 179 (Dist.) Dt: 05/8/16

WHEREAS, an in-House Inquiry was initiated against Shri Satnam Singh S/o. Late Sh. Gurdev Singh initially engaged as Beldar on muster roll on compassionate ground C/o. E.E.(South-West)-I, vide letter no.DJB/EO/AC(T)/2013/D-757 dt. 19 Dec.2013 issued by A.C.(T)/Inquiry Officer in connection with his unauthorized absence from duty. The charge in brief against Shri Satnam Singh S/o. Late Sh. Gurdev Singh was that he was running absent from duty without any information in office w.e.f. 01.10.2012. Notices bearing no.168 dt.26.10.2012, no.179 dt. 16.11.2012 and no.181 dt. 26.11.2012 were also served upon him by his concerned DDO but he did not respond. After that a final notice dt. 17.01.2013 was sent to the individual regarding attending duty, but he did not attend office as reported by his DDO.

AND WHEREAS, an in-House inquiry was conducted by Sh. S.K.Sharma, Enquiry Officer, who has submitted his report holding the charges as proved against the charged official. A copy of the Inquiry Report was sent to charged official for his comments. In response to same the charged official has accepted the charged of unauthorized absence since 01 Oct.2012 and also acknowledged in his written statement dt. 6.2.2015 that he was served notices but did not joined duty as he is not interested to work with Delhi Jal Board and further requested to dis-engage from the service of Delhi Jal Board.

AND WHEREAS, the matter was placed before the Disciplinary Authority who after examining the findings of Inquiry Officer, relevant record, considering the facts & circumstances of the case in totality and further considering upon the written statement given by the individual before
