- 3. The period of service rendered on look after charge will not count as officiation in the higher grade for any purpose.
- 4. The Competent Authority can terminate the interim/stop gap arrangement at any time without assigning any reason and giving prior notice.
- 5. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
- 6. That the promoted official will have to vacate the seat as and when the post is filled in on regular basis through DSSSB.
- 7. The above is further subject to outcome of Court Case of Sh. A.K. Awasthi & Others V/s Govt. of NCT of Delhi & Others pending in the Hon'ble High Court/CAT.

Further, they are directed to report to Director (A&P) for further posting.
