ORDER NO. 132

WHEREAS, Sh. Rinku S/o Sh. Raj Kumar was engaged on the post of Beldar on Muster Roll basis subject to certain terms and conditions inter alia that if anything found adverse about his past antecedents & verification of fake educational certificate, his services shall liable to be terminated vide office order No. 30 dated 21.02.2012 issued by the Assistant Commissioner (Bulk).

AND WHEREAS, at the time of engagement Sh. Rinku S/o Sh. Raj Kumar had informed that no criminal inquiry is pending against him.

AND WHEREAS, later on it came into noticed that FIR No. 32/05 under section 323/325/34 of IPC is registered against Sh. Rinku S/o Sh. Raj Kumar in Kotwali Delhi.

AND WHEREAS, an in-house inquiry was conducted by the Sh. S.K. Sharma, then Assist. Commissioner (D), in which charges of suppression of FIRs/Cases registered against him as well as submission of fake educational certificate, was proved.

AND WHEREAS, the in-house enquiry report was forwarded to Sh. Rinku S/o Sh. Raj Kumar Beldar on M/Roll and the representation submitted by him, was considered by the Director (A&P). After considering all the facts of the case, Director (A&P) being the disciplinary Authority had ordered to terminate Muster Roll services Sh. Rinku S/O Sh. Raj Kumar.

AND WHEREAS, the order, of the Disciplinary Authority were conveyed vide order No.18 dt. 10.9.2016 to Sh. Rinku S/O Sh. Raj Kumar Beldar on Muster Roll.

AND WHEREAS, Sh. Rinku S/O Sh. Raj Kumar preferred appeal before the Appellant Authority i.e Member (Administration) for reviewing the order on Disciplinary Authority.

NOW THEREFORE, Competent Authority i.e Member (Administration) taking a lenient view has ordered to engage him afresh to the post of Beldar on Muster Roll by giving relaxation in educational qualification and forfeiting his all past services as a last opportunity on the same terms and conditions mentioned in AC (B)'s O.O. No.30 dated 21.2.2012. He is further directed to report EE(E&M)-I Chandrawal for further duty. DDO is directed to get his age assessed through Mol within one month being an illiterate person.
