Please arrange to provide information on the following points under RTI Act;

1. Please inform if draft report followed by final report pertaining to Delhi SECC 2011-12, have got printed by Revenue Deptt on time? If so, please inform the exact printing dates of draft and final reports. After printing draft reports of all the 9 districts, if deptt. has been successful to obtain public views on the reports. Please specify in details.
2. Please inform about the transparency system that has been followed by the Revenue deptt. in all the 9 districts while disbursing remuneration to enumerators, supervisory staff, Charge Officers, SDOs, etc. Since there were numerous reports of non-payment to enumerators, supervisory staff (who were actually assigned census work) despite their frequent follow ups with respective SDMs offices for the last 3 years or so.
3. Could you please inform how many enumerators and supervisory staff out of 8289 and 1378 respectively have been lucky enough to get their stipulated remuneration from Revenue Deptt so far. District-wise list of beneficiaries may kindly be provided.
4. Since, Delhi SECC-2011 took about a 4 years time to get completed 33325 EBs (as stated; despite having repeated reminders and release of fund from Ministry of Rural Development (MORD), in this regard could you please inform about the EBs or household survey done by the deptt. yearwise basis. If done yearwise/part-wise, details of the same may kindly be provided.
5. As, Delhi SECC-2011 is being considered extra ordinary delayed survey in all over India, (MORD website itself reveals it), behind the ground scenario, what causes have been observed/noticed by the deptt. that led it to be counted in the last row. Kindly brief if any report is prepared by the deptt.
