ORDER

Notices were issued to the concerned. The matter was taken up for hearing on 05.05.2016, wherein, the appellant was present in person, Shri Ajit Singh, APIO (Saket) was also present in person and Shri Om Prakash, Panchayat Secretary was present for SPIO/BDO (South). The documents placed on record were perused. The appeal in the present case has been filed on the grounds of non-furnishing of any reply to the RTI Application dated 03.02.2016. The respondent parties could not place on record any material to show if any reply has been provided in the present case.

I, have considered the contentions & records placed before me. In the absence of any contentions on behalf of the SPIOs concerned, there is no other option but to accept the version of the appellant. The SPIO/SDM (Saket) and the SPIO/BDO (South) are therefore directed to provide appropriate reply to the appellant within 10 days of the receipt of this order. Further, they are advised for personal monitoring of the RTI applications to ensure that reply is invariably provided within the prescribed time limit of 30 days under the RTI Act, 2005.

The appeal is disposed-off, accordingly.

The Appellant shall be at liberty to approach the Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066, if he is not satisfied with the present order.
