ORDER

An appeal u/s 19(1) of the Right to Information Act, 2005 was filed by Shri Chander Swaroop Srivastava R/o 1/10745-B, Subhash Park, Naveen Sahadara, Delhi – 110 032 on 09/02/2016 on the ground of non-receipt of any information w.r.t. his application under the RTI Act, 2005 dated 13.08.2015. The appeal was taken up for hearing and accordingly disposed-off vide Order dated 23.03.2016, wherein, the SPIO/SDM (HQ.) was directed to provide appropriate information to the applicant within 07 days.

It has now been represented by the appellant and subsequent to the abovementioned order's dated 23.03.2016, the SPIO/SDM (HQ.) provided a reply dated 05.04.2016, which is different from what the information was sought. A perusal of the RTI application and the reply provided by the SPIO/SDM (HQ.) confirms the claim of the appellant.

Hence, the SPIO/SDM (HQ.) is hereby directed to provide pointwise and specific information to the appellant, as sought by him in his RTI application dated 13.08.2015, within 07 days of the receipt of this order. In case the SPIO is of the opinion that the information sought pertains to some other department/district, then the application be transferred under the relevant provisions of the Act.

However, it is found appropriate to mention here that the provisions of the RTI Act, 2005 stipulates pointwise & specific reply to be provided to the applicant but only information as held by or under the control of any Public Authority can constitute a right to information for which a citizen can claim access. This cannot be construed to demand creation of information. [CIC/WB/A/2006/00379 dated 21.12.2006]".

The Appellant shall be at liberty to approach the Central Information Commission, August Kranti Bhawan, Bhikaji Cama Place, New Delhi-110066, if he is not satisfied with the present order.
