ORDER

The proceedings U/s 111 of the Punjab Land Revenue Act in respect of land comprised in Khasra No. 262/191 situated in the revenue estate of village Adhchini, New Delhi initiated on suit filed by Smt. Munni Devi for partition against the respondent Sh. Azad Singh & Ors and application for installation of entrance gate and vacation of stay for one week.

Notices were issued to both the parties and heard the arguments and in the hearing of 05/02/2016, Sh. Ajay Tyagi on behalf of Sh. Rajeshwar Dagar and Mrs. Munni Devi & Sh. A. K. Sen (Advocate) for Mrs. Kela Devi they produced the compromise agreement alongwith application for withdrawal of suit by Mrs. Munni Devi (Petitioner). Both Mrs. Munni Devi & Mrs. Kela Devi are also present.


The contents of withdrawal application and compromise deed, wherein they stated that:

1. That the first party has agreed to abide by the existing wall between the property No. 21A and 22 of village Adhchini as shown in site plan.
2. The portion shown in red belongs to Sh. Pulkut son of Sh. Umed and the first party bearing property Nos. 21 and 21A.
3. That the portion shown in green belongs to Smt. Kela Devi wife of Late Azad Singh bearing property No. 22.
4. That both the parties shall abide by the measurement in the site plan duly signed by the parties hereto in token of its correctness.
5. That adjoining property No. 22A belongs to Sh. Narain Singh son of Sh. Rupan as shown in the site plan.

Further, they have also stated that, No dispute is left between the parties. The first party shall withdraw the case of partition in terms of the above.

I have gone through the contents of the withdrawal suit and compromise Deed dated 5th February, 2016 of both the parties and accepted the same for withdrawal of suit and disposed off the matter.
