**ORDER**

The following retired employees are hereby engaged for the post mentioned against their names on Contractual appointment at "**Last Pay drawn minus Pension drawn**" of remuneration for a period of one year or attaining the age of 65 years or till the regular appointment is made, whichever is earlier and posted as under on the following terms and conditions :

1. The engagement of the appointee shall be on full time as per the office hours/time.
2. The appointee shall be entitled to 8 days casual leave for a contractual duration of twelve months. No other leave will be admissible.
3. The contractual engagement would be effective w.e.f. date of joining in the respective place of posting.
4. The contract engagement of the appointee will be purely on temporary basis & the employer's Secretary (Revenue)/Divisional Commissioner reserves the right to terminate the contract at any time without assigning any reason. The appointee shall have to give one month notice or deposit an amount of equal to one month remuneration if he wishes to terminate the contract.
5. The contract engagement shall stand terminated with immediate effect if it is found at any stage that the employee is indulged in any, illegal activities or activities which the government, as employer, does not approve of.
6. The engagement on contractual basis is for twelve months from the date of joining. If at any stage it is found that contractual engagement is obtained on the basis of forged or fake documents, the engagement shall be terminated immediately and a criminal complaint shall be made with local police authorities besides recovery of all the remuneration paid by government.
7. The officials shall have to report in the respective place of posting latest by **01-02-2016**, failing which it will be presumed that they/he is not interested to the post and contractual engagement will be treated as cancelled without any further communication.
