



Accordingly, the proposal has been examined in AR Department and recommend the additional 2 posts of Personal Security Officer-Cum-Wireless Operator for the DCs/DMs of newly created districts i.e. Shahadara & South East, as detailed below, subject to the approval of Department of Finance, Planning Department and framing / constitution of Recruitment Rules for the post :

104. The instant matter of the Revenue Deptt. relates to creation of 02 posts of Personal Security Officer (PSO) – cum – Wireless Operators for newly created District Shahdara and South-East.

105. In this regard, the department has stated that Hon'ble L.G., Delhi, had concurred the creation of 09 (Nine) posts of Personal Security Officer (PSO) – cum – Wireless Operators in respect of 09 (Nine) Dy. Commissioners in the pay scale of Rs.950-1500 (Page-16/N in the linked file). The said sanction of Hon'ble L.G., Delhi, was conveyed vide order dated 03.03.1998 (Page-15/C). Further, vide Notification dated 11th September, 2012 the Revenue Districts of Delhi has reorganized by creating two new districts, namely Shahdara District and South-East District (Page-2/C).

106. As per the letter of Dy. Commissioner of Police, Delhi vide dated 29.09.1999, 09 Assistant Wireless Operators (Head Constable) have been posted with the Dy. Commissioner of 09 Revenue Districts to work as wireless operators and not PSO (Page-40/C in the linked file).

107. The administrative department has furnished the requirement of 02 more Personal Security Officer (PSO) – cum – Wireless Operators for newly created District Shahdara and South-East. The matter has therefore, been taken up with the A.R. Department, GNCTD. The AR Deptt. has recommended for the additional 02 posts of Personal Security Officer (PSO) – cum – Wireless Operators for the DCs/DMs of newly created districts i.e. Shahdara & South-East subject of approval of FD & Planning Department and framing /constitution of Recruitment Rules for the post (Page-9/N). Rs.6,40,000/- (approx.) has been calculated as financial implication in the aforesaid proposal and expenditure shall be debited under the two heads of Accounts, as mentioned at Para-93 on Page-20/N.

108. Accordingly, views / comments of the Planning Department has been solicited in this regard (P-16/N). However, the Planning Department, has agreed in principle, on the above proposal for creation of (02) two posts of Personal Security Officer (PSO) – cum – Wireless Operator for 'Shahdara' & 'South-East' districts, vide their note at Page-17/N & 22/N.

109. In view of the above, if agreed, FD may like to concur the above mentioned proposal for creation of (02) two posts of Personal Security Officer (PSO) – cum – Wireless Operator for 'Shahdara' & 'South-East' districts, subject to observance of codal formalities. Further, the administrative department may be advised to obtain the approval of the competent authority to get aforesaid posts created in the department.

- 101. Proposal on the file, re-submitted by Revenue Department, GNCTD through Finance Department relates for creation of two posts of Personal Security Officer (PSO) – cum - Wireless Operator in the pay scale (pre-revised) of ₹5200-20200 with Grade Pay of ₹2000/- with financial implication of ₹6.40 lakh (approx.) per annum for District Magistrates / Deputy Commissioners (DC) of two newly created districts viz. 'Shahdara' and 'South-East'.
- 102. The aforesaid proposal was earlier examined by Planning Department and agreed, in principle, on page 17/N (para 79). Responding to the observation of Planning Department, made at para 80 on page 17/N, regarding availability of budget for the said purpose, Revenue Department, vide para 93 on page 20/N, has replied that the expenditure on creation of these two posts of Personal Security Officer (PSO) – cum - Wireless Operator will be debited under plan head, namely, "MH: 2053, Salaries" under which sufficient funds are available in both the Districts.
- 103. Since the proposal has already been examined and agreed by Planning Department, Finance Department may take a final view.
