## Order under section 133 of CrPC

Whereas, it has been found that kite strings coated with powdered glass, metal or other such material to enhance its sharpness including the nylon strings are being manufactured or traded and sold to the end consumers in the NCT of Delhi;

- 2. And whereas, the use of such strings in kite-flying reported in the past have caused injuries including fatal injuries to the human beings, birds and animals and found a health hazard, traffic hazard and dangerous to the life and property of public at large and is, thus, a source of public nuisance;
- 3. And whereas, unregulated continuous manufacturing and / or trading of such strings in the NCT of Delhi is injurious to the health of the public at large as also the birds and animals endangering their lives and is a traffic hazard as also the cause of electrocution and therefore, a source of public nuisance;
- 4. And whereas, I, A. Anbarasu, Divisional Commissioner & District Magistrate, Delhi, am satisfied that it is necessary to take immediate steps to prevent such public nuisance. Further, I am also satisfied that the manufacturing and / or trading and use of any nylon string, strings coated with powdered glass, metal / any other material to enhance the sharpness of the strings used in kite-flying, is injurious to the health or physical comfort of the entire community of the NCT of Delhi;
- 5. And whereas, there is sufficient ground to proceed for immediate prevention and speedy remedy with the view to prevent injury to any person, to prevent any further danger to human life and safety and to prohibit manufacturing / trading and use of the said strings;
- 6. Now, therefore, in the exercise of the powers conferred on me under section 133 read with section 142 of CrPC, I, hereby, order as under:-

"from the date of publication of this order and temporarily for a period of one month, manufacturing, trading and use of any string coated with powdered glass, metal, or any other similar property to enhance its sharpness or any nylon string, which could be put to use in kite-flying, is prohibited and banned within the NCT of Delhi".

7. Notice is also directed to all such affected and aggrieved persons to show cause as to why the order should not be made absolute. Objections, if any, may be submitted in writing to the office of the undersigned within a period not exceeding 10 days from the date of publication of this order.
