ORDER

Whereas, Sh. Vinod Bhardwaj, the then Additional Chief Warden, Civil Defence, District SW, was dismissed by the Controller (CD) District Magistrate (South West) vide his order No. F. No. Distt/SW/CD/2016-1307-08 dated 6.5.2016 on complaint of misbehaviour by the Additional Controller (CW)/ADM(SW).


Whereas, Sh. Vinod Bhardwaj had filed an appeal under section 7 of Civil Defence Act, 1968 before the Appellate Authority on 9.5.2016 and requested his reinstatement in Civil Defence Organization in his previous post.

Whereas, Sh. Vinod Bhardwaj had cited many grounds in support of his prayer in the appeal. The main grounds of appeal are his continuous long association with the CD Organization since 2001, past service rendered without salary, higher academic and professional qualifications, specialization in Disaster Management and medal & appreciation received from the various organizations and the Senior officers including previous Controller (CD)/District Magistrate (South West).

Whereas Sh. Vinod Bhardwaj had joined the Civil Defence Organization in 2001 and since then he had served this organization till his dismissal vide order dated 6.5.2016. He has been decorated with medals and given appreciation letters from the various organizations, departments, and senior civil/public officers as well.

Whereas, in the event of the sensitive issue leading to such stern action and his dismissal from CD organization; it is also a fact that he did repent for his misbehaviour as soon as he realized it and had offered his unconditional apology too.

Therefore, in view of the above mentioned facts, considering his experience & expertise in the field of Disaster Management and appreciation letters/medals given by the previous DM (SW) and other officers and as proposed by DM/Controller (SW) and approved by Div. Comm/Director (CD) Sh. Vinod Bhardwaj is hereby being given another chance considering his credentials and contribution to the cause of the CD organization and is being reinstated to his previous position in the CD organization, District South West, with a warning to be careful in future and to respect the chain of command and hierarchy as mentioned in the code of conduct for Volunteers/wardens as defined in SOP vide CDSO No. 04/2015 dated 18.3.2015.
