The HOS concerned will be responsible for the verification of documents and are directed to process their engagement as guest teacher subject to fulfilment of essential qualification laid down under the Recruitment Rules (RRs) for the said post. Their respective engagement ID's have been generated and their details have been displayed in the guest teacher engagement module in the school concerned. Their engagement is subject to following terms & conditions of Guest Teacher Scheme:-

Their engagement as guest teacher is a stop gap arrangement made in interest of the students till the posts are filled on regular basis.

1. Guest Teacher PGT (Computer Science) will be paid remuneration @ Rs. 900/- per day subject to the maximum of Rs. 22500/- per month and Guest Teacher TGT (Computer Science) will be paid remuneration @ Rs. 800/- per day subject to the maximum of Rs. 20,000/- per month as approved by Finance Department, GNCTD vide U.O. No. 36/DS3 dated 08.06.2015.
2. The guest teachers are not entitled to any paid leave.
3. The guest teachers will automatically be dis-engaged as soon as the vacancies are filled by a regular teacher.

4. These guest teachers can also be dis-engaged on the grounds of poor performance/indiscipline.
