**Payment of wages to the security and sanitation workers**

Hon'ble Chief Minister, Delhi has noted that a number of workers of outsourcing sanitation and security agencies have not been paid wages for many months by the contractors. He has taken it very seriously. The communication received from the office of the Hon'ble Chief Minister is attached here with for strict compliance.

All private outsourcing agencies providing sanitation and security services in the schools and branches/stadiums etc. are directed to make payment of wages up to February, 2016 to all sanitation and security workers engaged by them immediately, if not yet paid.

The Contractors/ private outsourcing agencies providing sanitation and security services in the Directorate of Education are directed to submit 'No Pending Wages' certificates to the Caretaking Branch latest by 5.00 p.m. of Saturday, i.e., 12/03/2016 so that the same may be further submitted to the Hon'ble Chief Minister.

**OFFICE OF THE CHIEF MINISTER**

It has been brought to my notice that a number of contract workers working in schools like Security Guards have not been paid salaries for many months by respective contractors.

This is completely unacceptable. The following should be immediately ensured:-

1. Every Headmaster or Principal or concerned officer should certify that salaries have been paid to all contract workers working in schools up to February, 2016. Copies of all certificates should reach my office by 5.00 PM on 14<sup>th</sup> March, 2016. If salaries have not been paid to any employee, Education Minister must ensure that salaries are paid by then.
2. In each such case where salaries have been pending and are being paid now, reasons for the same should be given and responsibility should be fixed as to whether it was due to contractor's fault or because money was not released to contractor so far. This report should also reach me by 5.00 PM on 14<sup>th</sup> March, 2016.
