**ORDER**

**Subject:- Admission of EWS/DG category students in Private Unaided Recognized Schools of Delhi at entry level classes for the session 2016-17**

Directorate of Education had conducted the computerized draw of lots of online applications for admission of EWS/DG category in Private Unaided Recognized Schools of Delhi at entry level classes for the session 2016-17. On the basis of Computerized draw of lots, list of successful candidates was forwarded online to the concerned school through special module generated for EWS/DG category admission.

All the Private Unaided Recognized Schools were given directions to complete the formalities for admission under EWS/DG category and update the status of each and every student (Admitted/Rejected/Not Reported/Inwaiting/ Provisionally Admitted) on the online module available on the department website.

Vide this office order No. DE.15/Act-I/08/155/2013/6590-96 dated 12/02/2016, all the schools were given direction to admit the successful candidates till 22/02/2016 and upload the details on the online module by 23/02/2016. After that the last date of admission was extended upto 29/02/2016 vide this office order No. DE.15/Act-I/08/155/2013/6754-60 dated 22/02/2016.

Further, vide order No. DE.15/Act-I/08/155/2013/6947-6954 dated 29/02/2016 the last date of admission was extended upto 18/03/2016 and schools were given direction to update the status of EWS/DG category admission by 21/03/2016. Also, vide order No. DE.15/Act-I/08/155/2013/7633-36 dated 06/04/2016, the time limit was extended upto 08/04/2016 for updation of status of admission in respect of all the students of EWS/DG category.

Despite issuing various orders and directions by the Department, many schools have failed to update the status of each and every EWS/DG category student on the department module which is causing delay in conducting second round of computerized draw of lots.

Keeping in view that the process of second draw of lots has already been delayed due to above reason, **all the Private Unaided Recognized Schools are given last and final opportunity to accurately update the status of each and every EWS/DG category student allotted to them during first computerized draw of lots latest by 02/05/2016 till 6:00 PM. Thereafter, the EWS/DG category admission module of this Directorate shall be freezed and the vacancies for**

conducting the second round of computerized draw of lots shall be calculated on the basis of records available on the module on 02/05/2016 at 6:00 PM. The concerned school shall be liable/responsible for any discrepancy in the entries available on the module at that point of time.
