ORDER

Directorate of Education vide order No.DE.15 (172)/Act-I/2010/8255-8264 dated 28-04-2016(copy enclosed), issued directions to the school managements of Private Unaided recognized Schools (except Minority) running on the land allotted by the Government agencies, to ensure that they admit children from Economically Weaker Section in neighbourhood to the extent of 20% in all fresh admission for the academic session 2016-17 in accordance with the notification dated 30-12-2013 and submit the details of fresh admissions made in upper classes (i.e. Class II onwards) under Open (General)/EWS Category (free ship quota) of such classes in the module developed by the department, available at the link School Plant \rightarrow School Information \rightarrow Free Ship admission details (2016-17).

It was further directed that in the said module the school shall also upload the details of the students given fresh admissions in r/o Open (General)/EWS seats (free ship quota) from class II onwards. The school shall follow the instructions for granting admissions to EWS category as contained in the Notification dated 07-01-2011.

On scrutiny of data uploaded by the schools on departmental website, it reveals that only 154 schools have uploaded the details of EWS admission in upper classes which too were found wrong and erroneous.

Due to incomplete and erroneous data it is difficult to ascertain the number of students admitted under free ship quota in upper classes in the schools running on the DDA/Government land, which is to be submitted in the Hon'ble High Court.

Now, therefore, all the school managements of Private Unaided recognized Schools (except Minority) running on the land allotted by the Government agencies is hereby once again directed to upload the requisite data of EWS admission in upper classes in the online module at the link School Plant \rightarrow School Information \rightarrow Free Ship admission details (2016-17), within two days so that the requisite data may be submitted in the Hon'ble High Court before next date of hearing.

This issues with the prior approval of Competent Authority.
