Whereas, National Green Tribunal vide its various orders in OA 21 of 2014 titled "Vardhaman Kaushik Vs Union of India & Ors" regarding Air Pollution in Delhi, has passed certain directions for controlling environment pollution.

And Whereas, National Green Tribunal has also fixed compensation to be paid for violation in term of the Section 15 of the National Green Tribunal Act, 2010 for polluting the environment.

And whereas, National Green Tribunal vide its order dated 10.04.2015 has imposed compensation on construction related works as under:

....(XVII) (b) "If any person, owner and or builder is found to be violating any of the conditions stated in this order and or for their non-compliance such person, owner, builder shall be liable to pay compensation of Rs. 50,000/- per default in relation to construction activity at its site and Rs. 5,000/- for each violation during carriage and transportation of constriction material, debris through trucks or other vehicles, in terms of section 15 of the NGT Act on the principle of polluter pay..."

Copy of the order dated 10.04.2015 is enclosed as Annexure-1.

And Whereas, the order of the NGT are to be complied by designated officer as a decree/ order of Civil Court.

Therefore, in pursuance to NGT orders <u>Assistant Engineers of Public Works</u> <u>Department</u>, GNCTD, are hereby authorized to carry out surprise inspection/special drive for dust control measures in the construction activities of plots with built up area between 400 sq. mt to 20,000 sq mt. and levy compensation for violations as per their area jurisdiction.

The compensation amount so collected is to be deposited in Delhi Pollution Control Committee having Account no. 10166741672, IFSC Code SBIN0005715 in State Bank of India, ISBT, Kashmere Gate, Delhi.

Weekly action taken reports of inspections conducted, compensation imposed and compensation collected shall be submitted by the authorized officers to Delhi Pollution Control Committee, without fail.
