ORDER

In pursuance of order of Removal of (Licensing requirement, Stock limits, Movement Restrictions) on Specified Foodstuffs order, 2002, Delhi Pulses (Licensing of Dealers) Order, 1974 was rescind by the order of Lt. Governor of NCT of Delhi vide Order No. F.3(17)/2003/F&S/Policy/206 dated 12th July, 2004.

The Central Government vide Ministry of Consumer Affair, Food and Public Distribution, Department of Consumer Affairs, Notification No. S.O. 2642(E) dated the 28th September, 2015. has issued the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Food stuffs (Second Amendment) Order, 2015. In pursuance of this order No.F.3(17)/2003/F&S/Policy/206 dated 12th July, 2004 relating to Delhi Pulses (Licensing of Dealers) Order, 1974 has been kept in abeyance to the extent of the provisions of the Notification No. S.O. 2642(E) dated the 28th September, 2015 till 30/09/2016 in GNCT of Delhi vide order No F.3(4)/2002/F&S/P&C/Vol.I/106-125 dated 02/02/2016.

As per above order dated 02/02/2016 Delhi Pulses(Licensing of Dealers) Order, 1974 Para 8 Restrictions on possession of pulses (Stock limit) is applicable in Delhi as under :-

"Restrictions on possession of pulses:-

- (1) No dealers shall either himself or by any person on his behalf, store or have in his possession at any one time pulses all taken together in excess of 2000 quintals, in case he is a wholesaler and in excess of 50 quintals in case he is a retailer.

"Provided that no wholesaler dealer shall hold any stock of pulses for a period exceeding fifteen days from the date of physical receipt by him of such stock of pulses.

Provided further that only one sale/purchase transaction, if accompanied by physical delivery of stock, shall be permitted in respect of pulses between one wholesaler and another".

- (2) No producer specified in column(1) of the Table below shall store or have in his possession at any one time unmilled pulses in excess of the quantity specified in the corresponding entry in column(2) of the said Table and he shall not hold finished stock in excess of the quantity specified in the corresponding entry in Column(3) of the Table.

Provided that where any quantity of pulses is in transit, then, for the purpose of this sub-clause, such quantity shall not, during the period when such quantity is in transit, be deemed to have been included in the stock of the dealer in whom the property in quantity is retained during such transit in accordance with the terms of any contract or agreement in pursuance of which the quantity is put in such transit.

Provided further that pointing nothing in this clause shall apply to the commission agent who does not retain any consignment of pulses received by him for a period exceeding fifteen days from the date of its receipt he has got his license endorsed from the Licensing Authority for working as a "commission agent".

Provided that nothing contained in this item shall apply to:-

- a) exporters having import Export Code issued by the Directorate General of Foreign Trade from the purview of stock holding limits under the Essential Commodities Act, 1955 with respect of Pulses, edible oilseeds, edible oils for the stock meant for export;
- b) Stock essential commodities mean to be used as raw materials by licensed food processed food processors for manufacture of food products, from the purview of stock holding limits under the Essential Commodities Act, 1955.
- c) Retailers (Multiple Outlets) and Large Departmental Retailers from stock holding limits under the Essential Commodities Act, 1955".

"Pulses means urd, moong, arhar, massoor, lobia, raj-maha, muttur and gram including kabli gram whether whole or split and with or without husk but does not include products thereof, churi, chilka and kutti".

Therefore, all the Dealers/Organizations engaged in milling/trading/importing/trading of imported pulses are hereby directed to comply the above orders, failing which strict action will be taken under Essential Commodities Act, 1955 and Prevention of Black marketing and Maintenance of Supplies of Essential Commodities Act, 1980.
