**NOTIFICATION**

F. No. DHE4(68)/SFRC/14-15.- In exercise of powers conferred by sub-section (1) of section 6 of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence ) Act 2007. (Delhi Act 8 of 2007), the Government of National Capital Territory of Delhi constituted a State Fee Regulatory Committee vide Notification No. F.DHE (45)/2007-08/6962 dated 1<sup>st</sup> February, 2013 for the purpose of determining fee for pursuing courses in privately managed institutions offering different courses in the National Capital Territory of Delhi and to perform the functions assigned to it in the said Act. The said committee has submitted its report for the period of 2013-16.

Whereas the Government of National Capital Territory of Delhi has decided that the fee structure for the Academic year 2012-13 be extended to the Academic year 2013-14.

Now, in exercise of the powers conferred by sub-sections (3) and (13) of section 6 of the said Act, the Government of National Capital Territory of Delhi hereby extends the validity of fee structure of the academic year 2012-13 for the period 2013-14.
