NOTIFICATION

F. No..DHE 4(68)/SFRC/14-15 In exercise of powers conferred by sub-section (1) of section 6 of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act 2007. (Delhi Act 8 of 2007), the Government of the National Capital Territory of Delhi constituted a State Fee Regulatory Committee vide Notification No. F.DHE (45)/2007-08/6962 dated the 1st February, 2013 for the purpose of determining fee for pursuing courses in privately managed institutions offering different courses in the National Capital Territory of Delhi and to perform the functions assigned to it in the said Act. The said committee submitted its report for the period of 2013-16.

Further, the Government of the National Capital Territory of Delhi had decided that the fee proposed for academic year 2013-16 by the State Fee Regulatory Committee be notified for the period 2014-17. And had further decided that, for the courses having duration of four years and five years, the fee notified by the Government will be applicable for the entire duration of the course.

And further in exercise of the powers conferred by sub sections (3) and (13) of section 6 of the said Act, the Government of the National Capital Territory of Delhi had notified the proposed fees for the academic year 2013-16 given by the State Fee Regulatory Committee, for the academic year 2014-17 and for the year 2014-18 for four years course and 2014-19 for five years course respectively vide Extra Ordinary Gazette Notification No. F.DHE 4(68)/SFRC/14-15/9728 dated 19.02.2016.

Considering the fact that thousands of students have been affected by the revision of the fee with retrospective effect, the Government of National Capital Territory of Delhi rescinds the aforesaid Gazette Notification No. DHE 4(68)/SFRC/14-15/9728 dated 19.02.2016.
