F.NO.DHE-4(61)/2010-11/Part File/ - In exercise of the powers conferred by section 3 (g) read with sections 11 and 13 of The Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007 (Delhi Act 08 of 2007), and in continuation of this Directorate's Order F.No.DHE-4(61)/2010-11/Part File/4839-50 dated 21/10/2014, the Government of National Capital Territory of Delhi hereby designates the following agencies as designated agencies and the tests conducted by them shall be deemed as tests conducted by the designated agency for admission to relevant courses of Guru Gobind Singh Indraprastha University (GGSIPU), for filling up remaining vacancies, if any, after 31st day of July. Further if a need arises to compare scores of different tests, the percentile score shall be considered for admission:-

- (a) Common Law Admission Test (CLAT) conducted by National Law University, for admission to Guru Gobind Singh Indraprastha University, for B.A./BBA LLB Programme.
- (b) NITMCA Common Entrance Test (NIMCET) conducted by National Institute of Technology, for admission to Guru Gobind Singh Indraprastha University, for MCA Programme.
