2. The tax for previous months be deposited along with returns within a period of 7 days failing which action will be taken for assessment, imposition of penalty and other relevant provisions of Delhi Entertainment & Betting Tax Act, 1996 without any further notice.
3. All other conditions prescribed under rule of the DEBT Act, 1996 and rules framed there under have to be abided.
4. All tickets shall be produced for authentication to Area Entertainment Tax Inspector for sale thereof.
5. Applicant will obtain the NOCs from Delhi Fire Service, Licensing branch of Delhi Police and all other authorities concerned.
6. Any renewal of the permission will be considered only if due entertainment tax from the very beginning be paid.
7. This approval is only for depositing of due Entertainment Tax and the applicant will obtain the necessary NOC,s from other Departments as per norms.
