Provided that the members representing employees and employers shall continue to be member of the Committee so long as they are part of the organization shown against their respective name.


The terms of reference of the Committee are as follows:-

- (i) To review the extant formula for fixation of Minimum rates of Wages and the Dearness Allowance in respect of the Scheduled Employments for which the Appropriate Government is the Government of NCT of Delhi and give its recommendations.
- (ii) To consider and give suggestions on any other issue which may be assigned by the Government to the Committee during the course of its deliberations.

The Committee would be guided by the law laid down under Minimum Wages Act, 1948 and policy laid down by the Government.

This issues with the approval of Government of NCT of Delhi vide no. F.13(16)/MW/1/2008/Lab dated 01.04.2016 (42/N).


