**ORDER**

Whereas, Naveency CGHS Ltd., Plot No.2, Opp. Sanink Vihar, Pitampura, Delhi-34 is registered with this Department vide Regn. No.538.

Whereas, the term of the present Management Committee of the Naveency CGHS Ltd. has expired in June 2016.

And whereas, vide order dated 25-07-2016 Sh. O. P. Pandey, Asstt. Director of Education Department has already been appointed as Returning officer in the Naveen City CGHS Ltd under section 35 (1) of DCS Act & Rule, to conduct the election of the MC of the society.

Now, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi, in exercise of the powers vested in him under DCS Act & Rules, appoints Sh. P. C. Jain, Spl. Secretary (GAD), as Administrator in the Naveency CGHS Ltd. under section 35(5) of DCS Act, 2003, to manage the affairs of the Society and hold the election of the Managing Committee of society within Ninety (90) days from the date of your appointment. An honorarium of Rs.10, 000/- (Rs.Ten Thousand Only) Per Month will be paid to him from the society funds. The Administrator, on expiry of the period of 90 days shall not exercise any financial powers till the term is further extended by the competent authority.

Whereas, it is further directed that the Administrator has to comply the directions vide circular dated 29-09-2016 issued by the Joint Registrar of Cooperative Societies. (Copy enclosed)


