And whereas, reply submitted vide letter dated 15.9.2016 by the society was considered and decided to initiate the inspection under 61 of the DCS Act 2003.

Now, therefore, the Secretary-cum-Registrar Co-operative Societies, GNCT of Delhi in exercise of the power vested in him under DCS Act & Rule is pleased to appoint Sh. Navneet Singh, Financial Advisor to Commissioner, Delhi Police, as Inquiry Officer of the s Som Vihar Housing Maintenance Co-operative Society Ltd. u/s 61 of DCS Act. 2003, to conduct the investigation. An honorarium of Rs. 15,000/- (Rupees Fifteen Thousand Only) will be given to him for this purpose from the society funds.
