ORDER

Whereas The O.C.S. Friends Co-operative Group Housing Society Ltd., Plot No. 19, O.C.S. Apartments, Mayur Vihar, Phase-I Extension, Delhi-110091 is registered with Registrar Cooperative Societies Department vide registration No. 201 (G/H) under the provisions of DCS Act/Rules framed there and Bye Laws of the society.

Whereas complaints dated 24/04/2015 and 18/04/2015, of Sh. K. K. Verma (M.S. no. 17) alongwith forty members of The O.C.S. Friends Co-operative Group Housing Society Ltd. to the effect that the Managing Committee has committed various irregularities contravening the provisions of DCS Act and Rules including financial irregularities.

Whereas in view of serious allegations made by Sh. K. K. Verma (M.S. no. 17) alongwith forty members, the comments of Ex-President/Secretary, The O.C.S. Friends Co-operative Group Housing Society Ltd. were sought vide this office letter dated 12/05/2015.

Whereas two reply dated 26/05/15 and 08/08/2015 from the President/Secretary has been received.

And whereas the complainant (s) was given opportunity to give his views on reply submitted by M.C. Also, the complainant submitted his final submission with documents vide his letter dated 08/08/2015

Now therefore, Competent Authority has appointed Shri Ashok Kumar Navet, Assistant Registrar, Section-V, RCS office as an Inspecting Officer under section 61 of DCS Act, 2003 to inspect all the complaint / allegations leveled by the complainant against the M.C.

The Inspection report by Shri Ashok Kumar Navet shall be submitted to the Registrar, Cooperative Societies within two months from the date of receipt of this order and he shall be paid Rs. 15, 000/- (Rupees Fifteen thousand only) as consolidated remuneration from the funds of the society for conducting inspection.
