**ORDER**

Whereas, Surya Bansi Bandhu Coop. Thrift & Credit Society Ltd. is registered with this Department vide registration No.774/TC dated 22.5.1987 having its office at H-47 Gali No.16 Jai Prakash Nagar, Ghonda, Delhi.

And whereas vide order dated 4.2.2016, Shri K. R. Aggarwal, Dy. Controller of Accounts was appointed as Liquidator under section 99 of the DCS Act 2003 as the society did not responded to the notices under section 96(1) dated 25.8.2006 & under section 96(2) dated 4.1.2007 and it was presumed that the society is lying non-functional since it has not filed returns under section 32 of DCS Act.

And whereas an appeal against the order dated 4.2.2016 for recalling/reviewing/set aside/quashing was filed by Shri Kanchi Singh and others before the Competent Authority. It has been revealed that the Audit of the society has been conducted upto 2013-14 and election of the society has been conducted on 17.4.2015.

Now, the Competent Authority in exercise of powers conferred upon him withdraws the liquidation proceedings initiated against the society under section 99 of the DCS Act with immediate effect.

This issues with the prior approval of the competent authority.
