Whereas, The Z.A. Nagar CGHS Ltd., Plot No.14, Sector-22, Dwarka, New Delhi- 110075, is registered in this office vide registration No.1373/GH 1984.

And whereas, a request letter dated 10/07/2016 and 19/07/2016 for appointment of Returning Officer has been received from the President and Secretary of the Society to conduct the election of Managing Committee of the Society since the term of the society has expired in end of June, 2016.

In the light of the above facts, in exercise of the powers conferred under section 35 (5) of DCS Act, 2003, the competent authority has approved that the affairs of the society shall be managed by an Administrator in place of invalid/unauthorized existing managing committee of the said society, if any.

Now, therefore, Sh. Parmanand Pruthy, Joint Director (Health & Family Welfare) is appointed as Administrator in the said society u/s 35 (5) with the direction to manage the affairs of the Z.A. Nagar CGHS Ltd., and to hold the election of the managing committee of the society within 90 days from the date he assumes the charge as Administrator. He will also submit monthly progress report about the status of affairs in the society by 10th of every month. He will be paid Rs.10,000/- per month as honorarium from the society fund.
