Further, in the Special GBM held on dated 03/04/2016 wherein resolution has been passed to go for fresh election.

And whereas vide this office letter dated 23.05.2016 Sh. Pradeep Baijal, DANICS(Retd) was appointed as Returning Officer for conduction of Election in the society.

And whereas Sh. Pradeep Baijal have submitted his unablility to perform the duties of Returninig Officer.

Now, therefore, in exercise of powers vested under section 35 (1) of DCS Act, 2003, the Competent Authority is pleased to appoint Sh. M.L. Gupta, Adhoc DANICS (Retired), as Returning Officer to conduct the election of new M.C. as per DCS Act 2003 & DCS Rules 2007. The Society shall pay Rs. 6,000/- (Rupees Six Thousand) from the society's fund to the Returning Officer for conducting the election. The election shall be conducted within stipulated period as per the guidelines for the elections available in Rule - 53 and of Schedule - II of DCS Rules, 2007.
