ANNEXURE - I

Licensing conditions for Motor Driving Training Schools

1. The validity shall be subject to fulfilling the eligibility criteria & performance as prescribed by the Transport Department and certified by the competent authority.
2. The Licensing Authority may suspend the license of Motor Driving Schools under Rule 28 of CMVR, 1989, if found violating the provisions of Rule 27 and Rule 31 at any time.
3. The licensing authority in addition of suspension of license can impound the training vehicle and impose financial penalty.
4. The MDTS shall not be involved in procurement of driving license by canvassing or otherwise objectionable manner. The MDTS is authorized to impart training of driving only.
5. The MDTS shall not shift the premises or operate from any place other than the approved premises, without the approval of the competent authority.
6. The MDTS shall comply with the provisions contained in Rule 24, 27 and Rule 31 and maintain the records of trainees accurately.
7. The MDTS will impart the driving training as long as the license of MDTS is valid and not beyond it. In case of suspension of license, the MDTS cannot provide instructions to any trainee. The MDTS will surrender its license at the time of suspension to Licensing Authority. Transport Department can also impound the vehicle in case of violation.
8. The MDTS will not sublet the premises or the license to any other person.
9. The MDTS shall not use the premise for the purpose other than functions of MDTS.
10. The MDTS will ensure authenticity of issuance of form No. 5 and report periodically in Form 14 and Form 15 as and when required by the Licensing Authority.
11. The MDTS shall comply with instructions and norms issued by the Licensing Authority from time to time.
12. The MDTS shall emphasize on road safety awareness and shall impart training such manners as to promote road safety awareness.
13. The MDTS shall endeavor to develop such skills among the trainees that shall help the trainees develop such driving skills as required for driving on Delhi Roads. These skills may interalia include coping up with stress of driving and any emergency situation.
14. The MDTS will provide training as per training module explained in Rule 31 of CMVR and as per instructions issued by Transport Department from time to time.
15. If after issue/renewal of license any deficiency is found in records or functioning of MDTS at the time of inspection/audit during the intervening period, the license will be liable to be cancelled.
16. The licensee shall be required to comply with any amendments in the MDTS guidelines made by the Transport Department in public interest, within the time prescribed by the Transport Department.
